BELLEVUE POLICE SURVEILLANCE MAN'S APARTMENT

INCIDENT BELLEVUE, WA w/ POLICE officer Dennis L. RICHARDS

ISSUE A PROBABLY FALSE SPEEDING 60 in a 35 ASSAULT (TORN SHIRT) inside Def.'s VEHICLE THREAT "I'll be seeing you around" (after ASSAULT)

[START OF] 25+ NON-LAWSUIT COMPLAINTS TO AUTHORITIES 25 UNANSWERED i.e. NO ACTION

[START OF] 15 CIVIL LAWSUITS against POLICE/TOWNS 15 DISMISSED i.e. NO TRIALS

APPROX. IN MAN'S FBI CRIME REPORT!

MAN FILES COMPLAINTS BELLEVUE POLICE, ON 9/8/95 "ARREST" DETAIN MAN FOR CRIMINAL HARASSMENT, after phone calls to Police about complaint

Thanks to Benedict Authorities & Overseers START OF 85 MONTHS OF DETENTION, incl. Pre-Trial and Sentencing

MAY 12, 2005 INCIDENT SCRIVATE, MA

n=2 TRIALS 2008 DISORDERLY CONDUCT 2011 THREATENING COMMUNICATIONS

PREJUDICED (seems to protect Police accused of misconduct) - BEGINNING OF SIGNIFICANT ATTORNEY & JUDICIAL MISCONDUCT

SEEMING TO UNDERMINE THE MAN'S TRADE VICTIM CIVIL LITIGATION

12 CRIMINAL MISCONDUCTS n=10 PROSECUTED (n=9) OR PLEA BARGAINED (n=1) OR DROPPED (n=2) i.e. NO TRIALS CONCEALS POLICE MISCONDUCT

POLICE AS THE ONLY WITNESS (allows perjured testimony)

CONVICTION BARS LAWSUIT

REVERSED ON APPEAL w/ WHITEWASH OPINION 6 MONTHS in Plymouth Co. House of Corrections

THREATENING COMMUNICATIONS VICTIM BEING SUED by Def. HIGHLY SUBJECTIVE HIGHLY PREJUDICED INITIATED BY FALSE STATEMENTS AND PERJURY BY THE FBI IN ITS COMPLAINT TO OBTAIN AN ARREST WARRANT (before going to GRAND JURY)

5 YEARS in Federal Prison and/or time served

THUS, FERAVSON, MD (CLEVELAND, OH NEW YORK CITY...

THUS, A CULTURE OF PREJUDICE AND COVER UP OF POLICE MISCONDUCT
