

CALL FOR IMPEACHMENT OF US DISTRICT COURT JUDGE DOUGLAS P. WOODLOCK

Preamble

The public deserves to know of the derelictions of US District Court Judge Douglas P. Woodlock, while the elected Representatives serving the public are Constitutionally bound to oversee the Courts to assure that corruption and high crimes and misdemeanors are not part of our Constitutionally established and entrusted Courts.

Derelictions

- Douglas P. Woodlock condoned the documented, obvious, and prejudicial misconduct of Assistant US Attorney David G. Tobin, behavior in violation of the Code of Professional Conduct. Woodlock disregarded Petitions calling for the AUSA Tobin to answer to documented and provable misconduct, including providing false statements to the Court and knowingly false statements to a grand jury.
- Douglas P. Woodlock condoned the documented and obvious criminal conduct (including suborning perjury) and violations of the Code of Professional Conduct by attorney Stephen C. Pfaff, a “victim” in a case prosecuted by AUSA Tobin, who has conflicting ties to Pfaff clients.
- Douglas P. Woodlock forced an inexperienced, derelict, and incompetent Public Defender upon Jeffrey L. Clemens, accused of emailing threatening communications (associated with an arrest and charge preceded by ex parte communications by attorney Pfaff with the Civil Court) to attorney Pfaff...never mind that no threat of harm existed on the face of or even implied by any email communication. Woodlock refused to reassign a competent Public Defender, despite a 17 page Petition outlining numerous lapses, incompetencies, and ethical issues with the court assigned Public Defender Ian M. Gold.
- Douglas P. Woodlock allowed and condoned Jury Misconduct at a trial in May 2011 in allowing Juror #12 to allege fantastical, unfounded, and ridiculous fears of Defendant Clemens among the jurors. Woodlock excused a prejudicing and possibly tainted juror and failed to call a mistrial.
- Douglas P. Woodlock dishonestly represented an assault by US Marshals on Jeffrey L. Clemens on Friday the 13th of January 2012 as prompted by a so-called disruption by Mr. Clemens, even alleging criminal contempt on the part of Mr. Clemens, who was actually an obvious victim of unnecessary, brutal attacks by US Marshals (who have documented relations to parties averse to Mr. Clemens). Woodlock is involved in a concealment of multiple crimes (including assaults and perjury) and obstruction of criminal investigations by state authorities.

Petition to the US House

The Access To The Courts founder has drafted a Petition to the US House of Representatives calling for the impeachment of US District Court Judge Douglas P. Woodlock.
