This is the <b>ORIGIN of PREJUDICE</b></p>	<p><b>June 1995</b>  (Admin Complaint)  <b>August 1997</b> [Hired an attorney]  Attorney stopped work;  Filed but not served, a dereliction  <b>DISMISSED</b> re Lack of Prosecution  (Collusion suspected)</p>	<p>SEPT 8, 1995  Bellevue Police:  <b>Criminal Harassment</b> "Arrest" for calling about complaint against police (unanswered). Arrest noted in FBI Crime Report. OCT 21, 1994 police surveillance JLC's apartment</p>
<p>SEPT 27, 1997  (Los Angeles, CA) - Lobby of CAA  Gavin DeBecker &amp; Associates (private security ["<b>police</b>"] and threat management firm):  <b>Assault</b> and False Arrest of JLC</p>	<p><b>Sept 1998</b>  GDB Defaults  <b>DISMISSED</b> upon SJ despite withholding of incident video.  Second suit against GDB, CAA, and MGM; <b>DISMISSED</b> on Motion</p>	<p>OCT 1997  Charged with Trespass  (Case dismissed at start of trial – status not in FBI Crime Report)  Prosecutor showed defendant his FBI CR with 1 arrest (Bellevue)</p>
<p>NOV 12, 1999  (Mono County, CA)  Mono County <b>Deputy and CHP:</b>  Harassing pullover of JLC for false DUI in day; previously pulled over re alleged speeding by same officer</p>	<p><b>2000</b> suit filed against Douglas Co. (<b>SETTLED \$5K</b>, after county (in NV) avoided depositions)   An appeal in the CHP speeding case was already in progress</p>	<p>NOV 1999  Charged with <b>Failure to Yield</b></p>
<p>JAN 2, 2002  (Northampton, MA)  <b>MSP officer:</b> pulls over driver JLC for inoperative headlamp (an intermittent problem) – issues citation plus a false FTY charge; JLC drives to Barracks to see R/O's boss</p>	<p><b>Suit NOT FILED -</b>  <b>Civil Plaintiff feared for his life!</b>  MA State Police officer Brian Pearl at the Barracks had slammed his hands on hood and accuses driver of trying to run him over, after an other officer cited driver for FTY</p>	<p>JAN 2002  Charged with <b>Failure to Yield</b>, Resisting Arrest, OWI, and Assault with a Deadly Weapon (automobile). Charges followed a <b>bludgeoning Assault</b> by MSP police upon a second pullover.</p>
<p>May 12, 2005  (Scituate, MA)  <b>Scituate Police Officer:</b>  False Arrest (no reason given)  False Reporting &amp; Perjury [Report] (Incident: Driver had stopped at home of a Person of Interest in litigation in CA and stated who he was; he was asked to leave and left; officer pulled him over 3 minutes later, w/out permission, officer grabs paperwork out of the car.)  This is <b>PEAK PREJUDICE</b>, after the entire arrest history of driver (no trials, no convictions, no guilty pleas) was radioed to the officer; there were no open warrants.</p>	<p><b>May 2007</b> Against Town (False Arrest)  <b>DISMISSED</b> upon Motion after 9/18/08 conviction in shock trial;  <b>OCT 2009</b> Against Town (Malicious Prosecution)  <b>DISMISSED</b> upon Arrest by FBI after co-defendant and town counsel's ex parte communication with court.  <b>Assaulted x2</b> in court in 2012 by US Marshals, resulting in lawsuit;  <b>JAN 2014</b> Against USMS et al  <b>DISMISSED</b> re Immunity;  <b>July 8, 2013</b> Against Town et al  <b>DISMISSED</b> re Collateral Estoppel w/ different cause MP-DO/5<sup>th</sup>/6<sup>th</sup></p>	<p>May 12, 2005  Charged with Disorderly Conduct, after being told he could leave (when a Impersonating a PI charge could not be contrived); later charged with Unlicensed PI and with <b>Criminal Harassment</b>.   Scituate Police forwarded the falsified Reporting Officer Report to the US Secret Service and FBI on May 17 and 27, 2005.   Note: A 2007 lawsuit against the Secret Service agent and others was <b>DISMISSED</b> re Immunity!</p>
<p>SEPT 18, 2008  (Hingham, MA)  <b>Court Security Officer:</b>  violates Rights of JAC (Jonathan)</p>	<p><b>DEC 30, 2008</b> JAC v. TOS (Against Town of Scituate &amp; GDB)  <b>DISMISSED</b> one day after arrest by FBI of Civil Plaintiff's brother</p>	<p>Plaintiff's brother JLC pursued by his civil defendant-attorney and an FBI agent, an agency for whom the said attorney has represented.</p>
<p>NOV 1991 - June 1994 (Washington State)  (AHRO by involved <b>police officer</b> had been served on JAC by Bellevue Police in SEPT 1994)  OCT 25, 1994 (JAC arrested by <b>WSP officer</b> for reporting an assault by Bellevue Police upon JLC)  May 25, 2005 (Huron, OH) – <b>FBI</b> seizes JAC's confidential documents under false pretenses and without a search warrant.</p>	<p><b>June 1994</b> JAC v. Attorney DMG  <b>DISMISSED</b> upon SJ; case involved police and attorney misconduct  <b>May 1995</b> JAC v. Bellevue  Re Collusion for False Arrest  <b>DISMISSED</b> for lack of standing  <b>FEB 2006</b> JAC v. GDB re Violation of Rights, [Theft of IP, &amp; Misappropriation of Trade Secrets];  <b>DISMISSED</b> after judge ordered Plaintiff to amend (to eliminate Rights cause)</p>	<p>False Arrests and prosecution of JAC with known perjured testimony and false facts...thus, the lawsuits of 1994 – 1995. The 2006 case and dismissal is significant for its pre-emptive aid by the court in support of the defendant security firm (and consultant to the FBI, US Secret Service, and US Marshals Service).  <b>NOV 1994</b> JAC v. WSP Officer  <b>SETTLED</b> w/ signed false statement!  <b>*JLC = Jeffrey L. Clemens</b></p>
